**WHEREAS**, The City Commission determines that it is in the best interests of the citizens of the City of Stuart to support micro-transit and authorizes Budget Amendment # to the CRA Fund to authorize the two electric trams for the purpose of expanding the City's micro-transit system.

**SECTION 1:** The 2014-2015 Year Budget of the Transportation Impact Fund and of the City of Stuart, Florida, being Resolution No. of the City Commission of the City of Stuart, Florida, as amended, hereinafter the "Budget," is hereby further amended, as follows:

FROM: TRANSPORTATION IMPACT, FUND BALANCE:	\$67,000.00
TO: CRA FUND, AID TO PRIVATE ORGANIZATIONS	\$67,000.00

This authorization is to appropriate and expend funds in the amount of \$67,000.00. This action does increase the annual appropriations for these funds in the 2014/15 Fiscal Year CRA Fund Budget.

**SECTION 2:** Except as amended hereby, the Budget shall remain in full force and effect.

**SECTION 2:** This resolution will become effective upon adoption.
