**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA TO AUTHORIZE EXECUTION OF LEASE AGREEMENT BETWEEN THE CITY OF STUART AND CONGRESSMAN BRIAN MAST FOR THE CRARY HOUSE LOCATED AT 171 SW FLAGLER AVENUE, STUART; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.**

WHEREAS, the City owns the building at 171 SW Flagler Avenue in the City of Stuart, more commonly known as the “Crary House;” it having been donated to the City by Donna Dorney, in loving memory of her parents, Mildred Marie Moore and Elmer E. Moore; and

WHEREAS, Congressman Brian Mast seeks to use the Crary House as his District Office, and to execute a lease agreement with the City of Stuart for the 1,400 square foot building during his term of office; and

WHEREAS, the City Commission finds that it is befitting to use the Crary House as an office for a sitting Member of Congress, since one of the former owners, Evans Crary, was a state legislator beginning in 1936.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA that:

SECTION 1: The Mayor and City Clerk are hereby authorized and directed to execute a Lease Agreement between the City of Stuart and Congressman Brian Mast from January 2, 2021 to January 2, 2023. A copy of the executed Lease Agreement will be on file in the Office of the City Clerk.

SECTION 2: This resolution shall take effect upon adoption.
