RESOLUTION NUMBER 143-2017

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF STUART AND STUART MAIN STREET ASSOCIATION, INC. AND DOWNTOWN BUSINESS ASSOCIATION OF STUART, INC.; GRANTING A NON-EXCLUSIVE LICENSE TO OPERATE A WEEKLY OUTDOOR CONCERT SERIES UPON THE RIVERWALK STAGE AND ADJACENT PARK AREA; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, Stuart Main Street Association, Inc. (SMS) and the Downtown Business Association of Stuart, Inc. (DBA) desire to promote Historic Downtown Stuart; and

WHEREAS, SMS and DBA promote a positive downtown experience for residents, businesses, and visitors of the City and create a center for community life in Stuart and the larger surrounding community; and

WHEREAS, SMS and DBA have a legacy of presenting high-quality, well-produced, and well-attended special events which have become a part of the community's cultural life and traditions; and

WHEREAS, SMS and DBA desire to operate a weekly outdoor concert series; and

WHEREAS, SMS and DBA seek to execute a license agreement with the City of Stuart for the use of the Riverwalk Stage and adjacent park area for a weekly outdoor concert series.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF STUART, FLORIDA, THAT:

SECTION 1: The Mayor and City Clerk are hereby authorized to execute a non-exclusive license to Stuart Main Street Association, Inc. and the Downtown Business Association of Stuart, Inc. for the operation of a weekly outdoor concert series upon the Riverwalk Stage and adjacent park area.

SECTION 2: This Resolution shall take effect upon its adoption.
