At Ground Floor Farm, we believe in growing our town through food, art, and fun. Our urban farm features productive vegetable agriculture, a farm-to-table cafe and market, and a vibrant community space. We also have a really big fence, which we would like to convert into a large scale public art project.

Our vision is to provide space on our fence for a multitude of delightful and exciting murals. The murals will be visible on Martin Luther King Jr Blvd, as well as Bruner Pond Park. As time goes on and murals experience wear and tear, we will replace fence panels, making space for new works of art.

Taking inspiration from public art projects like Miami's Wynwood neighborhood, we imagine the murals bringing new life to our corner of downtown, encouraging community members to get out of their cars and explore this area of Stuart by foot.

THE DETAILS

We have space for 18-27 murals ranging in size from 8ft long to over 72 ft long. Murals will be painted directly on our wooden fence using professional UV resistant paints. Additionally, we will paint a mural on our building. We hope to showcase murals in a range of styles and techniques, painted by student, amateur, and professional artists from around the area and further afield.

HOW WILL WE PAY FOR IT?

We will work together with local businesses, community organizations, individuals, and families to raise funds for materials and artist fees. Sponsors will be able to choose a specific design to support, and their name will be prominently displayed on the corner of that mural. The more we are able to fundraise, the more murals we'll be able to put up on the fence. We hope to start off with at least 12 different designs.

TIMELINE

Once we recieve approval from this board to move project, we will begin promoting the project to potential artists and sponsors. We plan to fundraise throughout the early summer, while at the same time receiving submissions from artists. Once the funding campaign is complete, we will work with sponsors to choose artwork and notify artists. At that point, hopefully early or mid July, we will bring the final mural designs in front of this board for approval. We want artists to begin painting on September 1st, 2017, with all work completed by October 1st, 2017, in time for a big opening celebration.
